Certification of Vaccination

The purpose of this form is to take steps to prevent the spread of COVID-19, to protect the health and safety of all American Craft Spirits Association (“ACSA”) Annual Convention attendees, exhibitors, and other individuals interacting with the ACSA Annual Convention community during its event. If you fail to submit this signed attestation, you will be denied entry to the ACSA Annual Convention, including any related functions.

The information supplied by you must be accurate, to the best of your ability, at the time of signing this document.

ACSA is requiring all convention attendees and invited guests who enter the event premises, including, the host hotel of the GALT HOUSE, the convention center, and other related convention function space to:

- 1. Attest to full vaccination against the coronavirus (or affirm that you are not vaccinated due to a medical disability or firmly held religious belief),**
- 2. Wear a properly fitting mask covering both nose and mouth throughout the convention event space, unless eating or drinking; and,**
- 3. Respect attendees’ preferences for spatial distance.**

¹ The Centers for Disease Control and Prevention considers an individual fully vaccinated if they are: • 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or • 2 weeks after a single-dose vaccine, such as Johnson & Johnson’s Janssen vaccine If you don’t meet these requirements, regardless of your age, you are not fully vaccinated.

I understand that I must wear a mask and abide by the wishes of those present to physically distance myself as suggested on their convention badge regardless of the level of community transmission at all times throughout the ACSA Annual Convention. _____

I sign this document that the above is true and correct, and that I am the person named below. Checking “I decline to respond” does not constitute a false statement but I understand that I will not be allowed entrance to the ACSA Convention.

Consequence of Failure to Provide Information: Providing this information is voluntary. However, if you fail to provide this information, you will be treated as not fully vaccinated for purposes of implementing safety measures and you will not be allowed into the convention.

You must return this form prior to receiving your entrance badge into the convention and/or as part of your in-person participation at the ACSA Annual Convention and related events. The information will be kept confidential with ACSA staff for the duration of the convention and two weeks after its conclusion. It will then be destroyed to protect your confidentiality.
